Agfa Graphics' products are designed, developed and manufactured so that the production process, the transportation, the storage and the use of products, as well as the waste treatment at the end of the life cycle have minimal impact upon the environment. At least all Agfa products are designed and manufactured to meet all World Wide Regulatory requirements which include Product Safety, EMC, Packaging, and Environmental requirements.

Agfa Graphics will advise its customers, its employees and the authorities with an evaluation of its products and manufacturing processes, in all matters pertaining to health, safety and environment.

Agfa Graphics provides safety, health and environment information regarding its products.

- Safety Data Sheets (SDS) summarizes data about the composition of chemical substances and preparations and the relevant health, safety and environmental information.
- Article Information Sheets (AIS) contain similar data about Articles like Film, Printing Plates etceteras.
- Equipment Information Sheets (EIS) contain relevant health, safety and environmental data about equipment.

- Recycling Passes (RP) give information to customers and specialized waste collectors about hazardous components and valuable materials in end-of-life equipment.

Printing plates, chemicals and equipment are manufactured in several production sites all over the world.
